





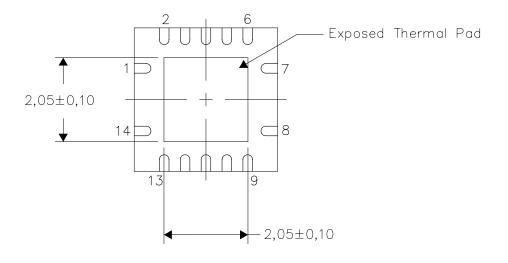

Exposed Thermal Pad Dimensions

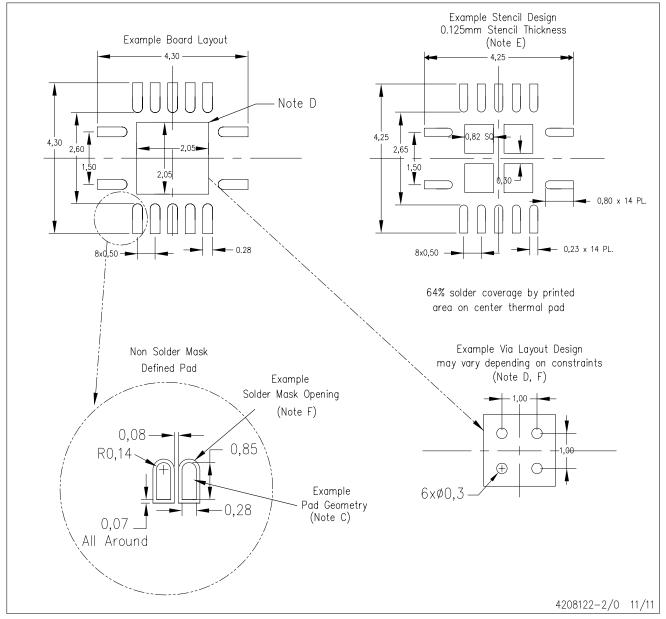
