

#### description/ordering information

The 'LV02A devices are quadruple 2-input positive-NOR gates designed for 2-V to 5.5-V V<sub>CC</sub> operation.

The 'LV02A devices perform the Boolean function  $Y = \overline{A + B}$  or  $Y = \overline{A} \bullet \overline{B}$  in positive logic.

These devices are fully specified for partial-power-down applications using I<sub>off</sub>. The I<sub>off</sub> circuitry disables the outputs, preventing damaging current backflow through the devices when they are powered down.






