

This device is fully specified for partial-power-down applications using I<sub>off</sub>. The I<sub>off</sub> circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.








# SN74LVC1G332 SINGLE 3-INPUT POSITIVE-OR GATE

VOLTAGE WAVEFORMS PULSE DURATION





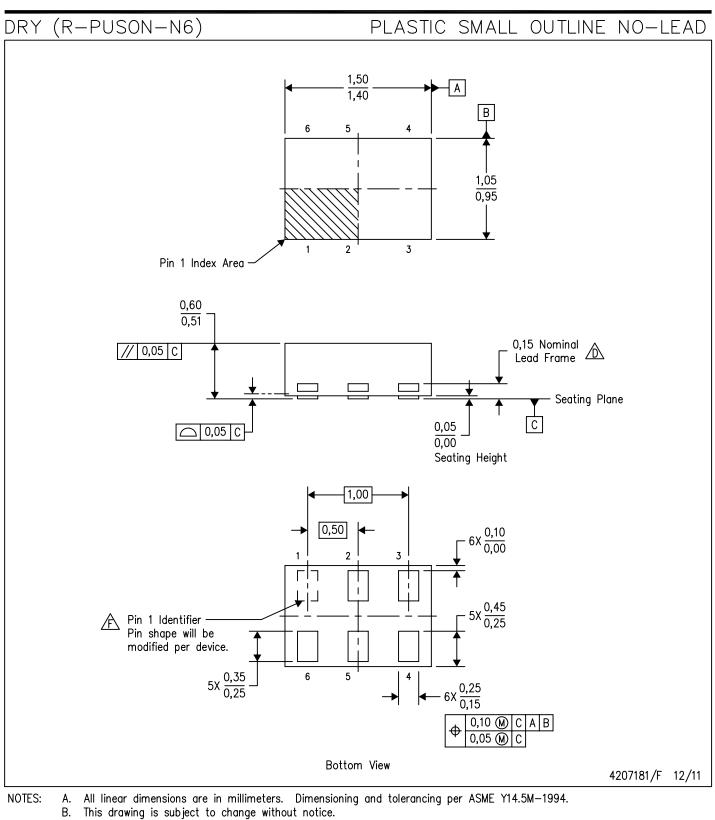
