


## **DESCRIPTION/ORDERING INFORMATION (CONTINUED)**

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

The SN74LVC2G241 is organized as two 1-bit line drivers with separate output-enable  $(1\overline{OE}, 2OE)$  inputs. When  $1\overline{OE}$  is low and 2OE is high, the device passes data from the A inputs to the Y outputs. When  $1\overline{OE}$  is high and 2OE is low, the outputs are in the high-impedance state.

To ensure the high-impedance state during power up or power down,  $\overline{\text{OE}}$  should be tied to  $V_{\text{CC}}$  through a pullup resistor, and OE should be tied to GND through a pulldown resistor; the minimum value of the resistor is determined by the current-sinking or the current-sourcing capability of the driver.


This device is fully specified for partial-power-down applications using  $I_{off}$ . The  $I_{off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.



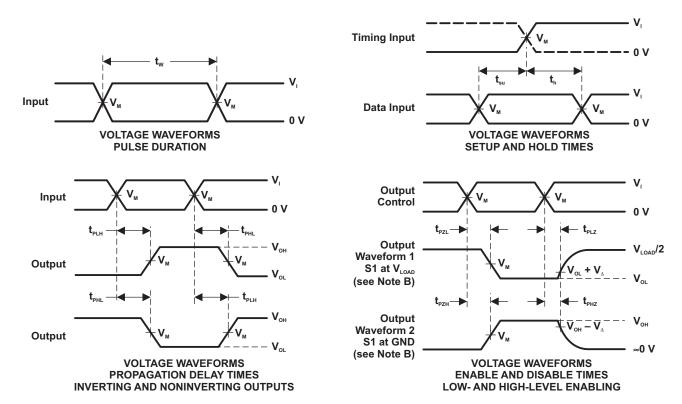

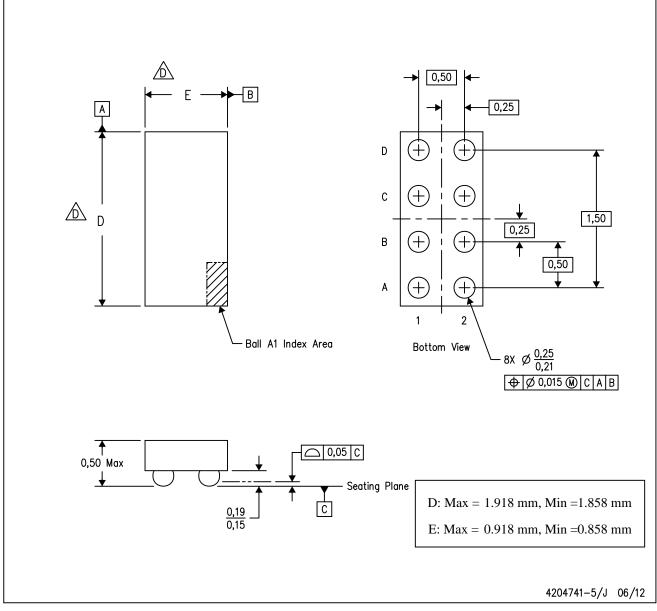
